Individual Retirement Accounts (IRAs)

There are a few things you need to know about your IRA, making gifts from your IRA now and in your estate plans.

If you are 70 ½ years or older and required to take distributions from your IRA:

- You can make a donation directly to a qualified charity such as the Priests of the Sacred Heart up to \$100,000.
- Gifting to charity offers the opportunity to lower your income tax, and is free of federal income tax on your withdrawal.
- An IRA rollover gift doesn't count toward the 60% annual limitation on charitable gifts.

Options if you are considering a gift of an IRA through your estate plans:

- Transfer of an IRA to a spouse in your estate plan is possible (similar required distributions will apply).
- Transfer of an IRA to a child or non-spouse can have negative tax consequences and can greatly diminish their inheritance.
- Transfer of an IRA to charity can be very tax efficient. It may provide more funds for a charity and heirs alike.
- When done properly, charitable donations of retirement assets can minimize the amount of income taxes imposed on both your individual heirs and your estate.

Donating an IRA to charity upon death:

Naming a charity as a beneficiary for an IRA or other retirement assets upon your death, rather than donating retirement assets during your lifetime, may have multiple benefits:

- Neither you, your heirs nor your estate will pay income tax on the distribution of the assets.
- Your estate will need to include the value of the assets as part of the gross estate but will receive a tax deduction for the charitable contribution, which can be used to offset the estate taxes.
- Since charities do not pay income tax, the full amount of your retirement account will directly benefit the charity of your choice. You have the opportunity to support a cause, like the Priests of the Sacred Heart, as part of your legacy.
- It is possible to divide your retirement assets between charities and heirs according to any percentages you choose.

Peace of Mind ... Guaranteed!

If you've established your Will, you understand the peace of mind that comes with this simple act. Sadly, it often takes the death of a close friend or a family member to motivate a person to prepare their Will.

And, frequently, people who have established their Will wonder why they procrastinated so long.

The Priests of the Sacred Heart wants to do everything possible to help give you peace of mind. The steps in preparing your Will are not complex and start with requesting our free Guide to My Personal Affairs, reading the accompanying material and making an appointment with an estate planning attorney. Your completed Will should:

- Reflect your wishes instead of the courts appointing a personal representative, you select the person best equipped to handle this responsibility.
- Make provisions for family members and potentially establish a Trust to benefit your spouse and reduce estate taxes.
- Disburse assets according to your wishes.
- **Identify charities** to receive special bequests.
- Be legally valid.
- **Be up-to-date** (you'll need to review your Will every three to five years).
- **Be easily amended** either by adding a codicil or by having it redrafted.

You will want to store your Will in a safe place. Keep a copy in your home files and the original in a bank safety deposit box. Be sure



your personal representative knows how to find your Will.

People who have their Will prepared often ask **why** they lived with a nagging apprehension about what would happen if they died without a Will. Those feelings are gone once your Will is prepared – you'll have a sense of well-being and inner calmness. And, you'll be surprised what little time and effort it took!

If you **do not** have a current, valid Will or comprehensive Living Trust, the Priests of the Sacred Heart urge you to take care of this very important matter for your peace of mind and for those you leave behind.

The Ease of a Donor Advised Fund

A Donor Advised Fund is a tax-wise fund to help you manage your charitable giving.

Your Donor Advised Fund is also an effective way to put your vision for a better world into action!

Setting up a Donor Advised Fund is an easy process and can be handled through a number of charitable administrators, such as Fidelity, Schwab, Vanguard or many others. The minimum beginning contributions are as low as \$5,000 and an immediate tax deduction is earned for your opening contribution and for any additional contributions to the fund.

You advise* your fund administrator which charities you would like to support and checks are sent out on your behalf. Your next of kin can carry out the legacy you have established by advising your fund administrator upon your passing.
